

Dear Trip Participants:

The League App., Inc. (the “Company” or “the League”) is excited that you will be joining it for a river cruise, operated by U by Uniworld from August 11, 2018 through August 18, 2018 (the “Trip”). We think the Trip will be great – and hopefully lead to some romance! That said, we wanted to make sure you (and all Trip participants) were aware of some basic safety rules since your safety is our primary concern. (We can’t have fun if everyone isn’t safe!) Important Safety Tips For The Trip

As a user of The League’s app, you probably already know that The League strives to limit its services (such as the Trip and the app more generally) to high-quality individuals; The League does its best to screen out the tire-kickers, the one night stands, and the duds. Despite this, it is still important to use common sense and take normal safety precautions while on the Trip and/or using The League’s app. For example:

- Users of The League’s app (“Users”) should meet new people in public and avoid going into private places with them until they get to know them and feel as though the other person is trustworthy.
- When going on a new date, Users should let someone else know where they are going and when they are expected to return. Users should designate someone to check in with during the date. Taking this precaution while on the first few dates (as opposed to just the first) with a new person is a good idea.
- The League does not screen users or Trip attendees for sexually transmitted (or other) diseases. Users are encouraged to take common sense measures to prevent transmission of disease.
- Users and Trip attendees should drink alcohol responsibly.
- Trip attendees should review the U.S. Secretary of State travel warnings about precautions to take while traveling. For this Trip, warnings for France can be found at <https://travel.state.gov/content/travel/en/international-travel/International-Travel-Country-Information-Pages/France.html.html?wcmode=disabled>.

- If Trip attendees take any medication, they should bring such medication from the U.S. (as opposed to trying to get it in France). Trip attendees are encouraged to purchase medical insurance that will cover them in France.
- Trip attendees (and Users) must comply with all applicable laws at all times. Trip attendees are reminded that foreign countries may have different rules than the U.S. regarding drug use (among other things). Trip attendees (and Users) should always keep local laws in mind regarding all aspects of behavior, including, but not limited to, sexting.
- Trip attendees should make copies of their passports. It is a good idea to email a copy to oneself or save it to the cloud for easy access abroad should it become lost or stolen.
- Trip attendees should inform their credit cards and banks that they are traveling so they have no problem accessing money abroad.
- Trip attendees should use the safe located in their cabins on the ship to store valuables.
- Trip attendees should keep their cabin doors closed and locked at all times.
- Trip attendees should not sit on ship railings, enter any prohibited areas of the ship, jump off of the ship, swim in the Seine (unless it is a designated swimming area), or otherwise endanger themselves.
- Trip attendees should not allow unknown persons to enter their cabins, nor should Trip attendees enter cabins that are not their own unless they were explicitly invited into such cabins.
- Trip attendees should only engage in sexual or romantic behavior after obtaining explicit, affirmative consent (i.e., a conscious and voluntary agreement to engage in sexual activity). Silence should not be presumed to be consent. Each person involved in the sexual activity should ensure they have the affirmative consent of the other or others to engage in the sexual activity. Lack of protest or resistance does not mean consent. Affirmative consent must be ongoing throughout a sexual activity and can be revoked at any time. The existence of a dating relationship between the persons involved, or the fact of past sexual relations between them, should never, by itself, be assumed to be an indicator of consent.
- Trip attendees are encouraged to refrain from sexual or romantic activities if any party to the sexual or romantic activity is under the influence of alcohol or otherwise impaired (e.g., asleep, unconscious).

- Trip attendees should not engage in physical force, threats, or intimidation.
- When not on the ship itself, Trip participants should exercise caution regarding where they go. They are encouraged to stay in well-traveled, well-lit places, and to let others know where they are going.
- Trip Participants are encouraged to put local emergency numbers in their phones (and to have an operating phone during the Trip).
- The League may ask Trip participants to leave certain events on the Trip if, in The League's sole discretion it determines a Trip participant has consumed too much alcohol, has engaged in unwanted sexual activity or advances, or is otherwise not behaving in a safe manner. The League may also, at its sole discretion, require Trip participants to leave the Trip if The League, in its sole discretion, believes the Trip participant has engaged in unwanted sexual activity or is otherwise not behaving in a safe and lawful manner. If that happens, the Trip participant will not be entitled to a refund for the remainder of the Trip. In addition, The League may ban such persons from using its app or attending other League events in the future. If a Trip participant is banned from using The League's app, the Trip participant will not be entitled to a refund if the Trip participant paid to use the app (or pre-paid for any other Company events).
- In order to keep yourself and others safe, if any Trip attendee makes you feel uncomfortable (including, but not limited to, engaging in unwanted sexual activity or advances), please let The League know as soon as possible. You can do so by emailing **tripsafety@theleague.com**. Someone on our Customer Support team will be monitoring this account. We also encourage anyone who has encountered or witnessed unsafe (or potentially unsafe behavior) to report it to **tripsafety@theleague.com**. Likewise, Participants can always feel free to email **seinecity@theleague.com** for support if any issues arise.

ADDITIONAL INFORMATION ABOUT THE TRIP

- Aside from the mingling activities related to the Trip, which are provided by The League, all services on the Ship are provided by U by Uniworld, including the serving of all food, beverages, and the maintenance and upkeep of ship facilities.
- The League may recommend to U by Uniworld that it discontinue alcohol sales to Trip participants who appear to have consumed too much alcohol. The League urges all Participants to drink responsibly at all times.

- All Trip participants, as Users of the app, remain bound by The League's End User License Agreement and Terms of Service (the "EULA"). The EULA can be found here: <http://www.theleague.com/privacy-terms/>.
 - Any disputes regarding the Trip shall be resolved through the dispute resolution mechanism described in the EULA. **Trip participants should be reminded that the EULA contains a mandatory arbitration provision.**
 - Please be reminded that under the EULA, you agreed not to harass, abuse, harm or advocate or incite harassment, abuse or harm of another person or group.
 - Please also be reminded that the EULA states: "We reserve the right to suspend or terminate your account and prevent access to the Service for any reason, at our discretion. We reserve the right to refuse to provide the Service to you in the future. TLA ["The League"] may review and remove any of your Social Content at any time for any reason, including activity which, in its sole judgment: violates the EULA; violates applicable laws, rules, or regulations; is abusive, disruptive, offensive or illegal; or violates the rights of, or harms or threatens the safety of, Users of the Service. You are responsible for any claims, fees, fines, penalties, and other liability incurred by us or others caused by, or arising out of, your breach of this EULA and your use of the Service."
 - Additionally, please remember the EULA states: "YOU ARE SOLELY RESPONSIBLE FOR YOUR INTERACTIONS WITH OTHER USERS, INCLUDING AT ANY TLA-HOSTED OR SPONSORED EVENTS.
